1. June 14, O&M Shortages Subcommittee Summary JH 30

NIU: <u>WI DPI - Orientation and Mobility Certificate Program Informational</u> Presentation.pdf PSU: PSU O&M Program Slides

CK: TVI rep, like the pros and cons from the subcommittee. She wants to ensure we have qualified O&M Specialists in the field. NIU has a high-quality established program, has a long-standing history that is sustainable and vision professionals from NIU are very well trained. She feels that sustainability is vital. She feels that we have had a few programs recently and we need sustainability at this next turn.

CO: Is this hybrid?

JH: This is hybrid with some remote courses and the in-person required sessions would be supported by COMS in Wisconsin so Wisconsin participants don't have to travel to Illinois.

TS: Supports the proposal. It's unfortunate that Wisconsin cannot sustain a program, but she supports the NIU program with well-trained TVIs and O&M Specialists to serve Wisconsin students.

JH: Sustainability is difficult. Partnering with an existing and strong program, such as NIU, with a focus on the needs of Wisconsin students is vital.

CK: funding is important, the HEAB funding with NIU partnership is vital.

JH: Subcommittee has one question about HEAB funding. How will it affect HEAB funds because these students would only take one course at a time. This is a question for another date or time. NIU gave a fabulous presentation to our subcommittee. They outnumbered the subcommittee members and provided a professional presentation which was detail oriented.

Dr. Kelly: Thank you to Wisconsin. She reported that this is the 60th anniversary of the NIU Vision program and we have done more hybrid work, especially due to COVID. Our long standing well recognized program continues to evolve with the times, and we already feel a strong reciprocity with Wisconsin. We are confident in the program we presented to support growth and also to support exploration of those who are new to the field. We are enthusiastic and we are very interested in expanding to those who are

new to the field of O&M. We would build data from this proposed programming and with this certificate program we can build toward what Wisconsin needs.

Dr. Hedin: The in-state tuition might also be a possibility. NIU will be exploring this with their financial team.

JH: WMU was also approached by the subcommittee to offer a presentation to Wisconsin's Advisory Council, but they did not present. This does not mean that other universities that are adjacent state programs cannot still accept Wisconsin students, but this program proposal for NIU for an O&M Certificate will be presented to the State Superintendent.

CK: Is this only for vision professionals?

Dr. Kelly: Anyone with a TVI, CATIS, CVRT degree could enter this certificate program.

JH: Thank you to NIU to Dr. Kelly and Dr. Hedin for presenting to the subcommittee and for attending today.

JH: Additional questions from subcommittee.

Where to host? Depends on who applies. Beyond Vision, Vision Forward, WCBVI, northern location

Cost? Could HEAB funds be used to cover costs? HEAB to NIU directly.

How would WI choose WI instructors? Depends on who applies regarding location

Questions:

AR: The final internship is 350 hours. Would that need to happen over the course of a summer at one of those locations. Would a student be able to complete those hours at the summer location.

JH: That would need to be a discussion between NIU, the Wisconsin COMS supporting the program and the student. This is a new path, and we would need to determine what this would look like.

WL: We had a similar situation in the past with a TVI who was almost an O&M Specialist and needed some internship hours. We paired this person with another certified person, and they were able to provide instruction with students but only after the instruction was initially provided by the O&M Specialist.

KR: An O&M Specialist cannot provide direct instruction unless they have completed the training program, including the internship.

JH: There is not a provisional license in O&M, you must complete all of your coursework in the program prior to being able to work as an O&M in Wisconsin.

Motion to add to the annual report that DPI engage in a conversation with NIU with the goal of forming a partnership to increase the number of O&M Specialists in the state through a hybrid program with NIU that would include online instruction and in-person instruction that would occur in Wisconsin, following NIUs existing O&M curriculum. With a projected start date of Fall 2024.

Answer: Only licensed educator can carry out SDI minutes;

3. Where do you put paraprofessional services in IEP.

Answer: supplementary aids and services. See above bulletins under D.

Discussion and action items on #1: Are the categories equitable, for example the additional support for students who are deaf and hard of hearing who have educational interpreters, for example, do the students who are blind and visually impaired have equitable supports. Is the pay equitable for these positions and extra skills as well? There is a degree for educational interpreter and also a licensure category in the Division of Safety and Professional Services (DSPS).

DS: Madison school district had addressed the Certified Braille Transcribers within their district and moved to equitable and commensurate pay with their Educational Interpreters.

ENG: Thank you for sharing this resource and a district who had already done the work. JH: This could be a good subcommittee for Guadalupe, when her membership is official. DS: Will bring the request for more information about what is available for paraprofessional training through the American Printing House for the Blind (APH) Hive or through the Council of Schools and Services for the Blind (COSB) and Outreach of Schools and Services for the Blind (OOSB).

Category 9, Other Dr. Routier Concordia University of Wisconsin – Several graduate students who have completed licensure requirements as of 6-14-2023 and will be applying for the DPI VI License after working under provisional licenses so they already have jobs as TVIs in Wisconsin. CUW has made the decision to discontinue the graduate visual impairment licensure program that has been hosted over the past three years. They are not accepting any new students, but the current students will be finishing their programs.

JH – thank you to CUW and Dr. Routier.

- Dr. Routier CUW If all the current students finish, we will have approximately 14-16 TVIs who have been added to the field in Wisconsin over the course of the program.
- CK We heard from the O&M Subcommittee. Moving forward, how can we work toward fulfilling the needs that CUW program was fulfilling?
- JH She learned about this change from CUW shortly after hearing the presentation from NIU about O&M and she asked if NIU would be interested in discussing with us the possibility of helping with something similar for TVI. NIU said they would be happy to work with Wisconsin and that the door is open if we want to discuss this with them.
- CK Is there a timeline with this type of need, I don't want to make decisions in haste, but is there something from this meeting we need to ask to discuss right away?
- JH that is a great question. Not being DPI, I don't know. If we wanted to gather information, this is a point where NIU is currently writing for their 5-year grant cycle, so it is probably a good time.
- CK Can I make a motion right now as the TVI rep to make a motion to ask to address this need with NIU.
- JH Daniel Parker, we received presentation at our O&M Subcommittee from NIU to add a certificate for O&M with NIU, using a model that would use the NIU Curriculum but have in person instruction occur in Wisconsin. O&M Programs are actually more difficult to sustain than TVI training programs because there are fewer O&M specialists than there are TVIs. NIU's Vision Disabilities program for O&M, and their business services team, presented to the subcommittee. If we wanted to ask NIU to present about a TVI training program, they would be very open to this.
- CO I would support this. We've tried a number of TVI programs in the state and I think we should follow this track.
- JO I support the idea, the need as Colleen mentioned still exists and we need more licensed TVIs. I do recommend proceeding with a little caution, I don't want to rush into it too quickly. We're taking on a lot to take on the O&M certificate program, but I just think that I want our passion to drive us but not to drive us into a wall. Enthusiasm is great, but let's do this thoughtfully and right.
- LB I am not part of the O&M Committee, but since there are discussions with NIU, then I would think that even for TVI and Assistive Technology, would it be possible for me to sit in on those meetings?
- JH Yes, let's circle back to this request you have Linda.
- JR I agree with being cautious, I think that it would be good and would behoove us well to see what went well and what could be done better. NIU is producing some

amazing teachers in the field. One of the things we discussed with the O&M Subcommittee was flexibility and we know that NIU wants to support Wisconsin. Maybe another subcommittee to address these needs. We could look at the same things that the O&M subcommittee did to explore existing programs.

JH – this is probably too big to address right at this moment, we do know that we need to continue gaining TVIs. This is probably too large of an issue to address just at this moment, and we want to respect the fact that we do still have a TVI program in Wisconsin. This would be a way to plant seeds with how we want to proceed.

CK – Next steps would be a subcommittee to look at this. This may need a faster pace than other subcommittees have moved in the past.

JH – vote to create a subcommittee for TVI Training needs in Wisconsin with Colleen Kickbush as the lead for that subcommittee
