Dawn Anderson – Representing W MI TVI and O&M Programs. WMU qualifies for WI HEAB loans. Work closely with DPI to make sure their programs align with the WI requirements. Certified teachers only. Many programs are offered online, but onsite programming is offered, as well as summer sessions for the hands-on portions of the curriculum. Student teaching can happen on the job when possible as well. Two O&M programs – one focused on adults, and one focused on children. Those who graduate from either program can sit for COMS. The children's program includes coursework on itinerancy, IEPs, etc. As a training program, need professionals in the field who can supervise internships. CATIS program will be soon be accredited by AER. (NIU will be accredited soon, too. NIU was first in 2016)

WL – Regarding HEAB loans – DA – Can confirm that it is a pot of money that if there are more students drawing from it, each student will receive a smaller allotment. DA – Pete Zammuto has worked very hard to make the HEAB funding work for the students.

However, we have not been able to meet together with DHS to finalize this before sharing back with the advisory council because DHS-DPI quarterly meeting was cancelled due to scheduling conflicts. Note that we did not have resources to create a full guidance document like special education in plain language but did summarize key responsibilities of our agencies related to B-3 services that could go with the statutory chart that we developed.

#### **Subcommittee Updates and Discussion**

- 1. TVI training program Subcommittee JH and JR Per DPI licensing, an out of state IHE needs to partner with an in state IHE. Discussion on combining the TVI and O&M Training subcommittees, but due to the large differences in licensing requirements for those areas, they will remain separate. TS is there a timeline? JH It is somewhat already in motion, and we can request updates, perhaps for the next Council meeting.
- 2. Braille subcommittee CO Met yesterday with the DPI Division for Academic Excellence (DAE) updated them regarding what we are looking for for braille standards to match Common Core expectations for each grade levels. DAE had good questions, especially regarding learning about this area. Discussed what the process and procedures would be to develop a document for Wisconsin. Looked at other state's processes. DAE team will go back to DPI to explore that process. Next meeting January 30. Jennifer Ottowitz The ELA and Math Standards for Wisconsin will be updated in 2026.
- 3. Assistive Technology JH Have had a lot of good discussion regarding looking at the need to support vision professionals in the area of Assistive Technology. Discussed

competency exam, but at the moment providing resources. Micro-Credentials? Like Screen Reader Savvy program that Amy Snow created. This could be a way to share information in a quick way, give opportunities to push trainings out through partners like APH or Humanware or other vendors. Looking at ways to offer the support and have it available. Subcommittee appreciated the incentive program to complete a training session on the Juno Magnifier, then receive a Juno Magnifier. Encourage more programs like this. A loan library for teachers to be exposed to the equipment prior to them going to students so the teachers can learn.
